ST/SC candidates shall be recruited, even if they do not initially qualify in the type test, and if they are otherwise qualified, shall be given a consolidated pay for a period of 6(six) months at the end of which they should be tested again in Typing and if they do not qualify even at the end of 6(six) months, they will continue to be employed in the consolidated pay till such time they qualify and shall not be entitled to any annual increment.</p>

The aspiring candidates within the age limit of minimum 18 years and maximum 40 years of age (relaxation by 5(five) years in case of SC/ST/PH candidates) as on 10<sup>th</sup> August, 2015 should submit applications along with required information in the office of the Concerned District Forest Offices & also obtain a token of acknowledgement. 


